The Governing Body structure

Llangynidr School Governing Body has a structure of sub-committees and officers with individual responsibilities in order to ensure quick decision-making and an effective overview of the school, its standards and any other issues which need attention. Some of our committees or officers are statutory and required by law but others have been put in place to fulfil a particular role or area of responsibility, such as school standards.

We decide which governors are attached to each committee or individual responsibility in a special meeting in September – the Annual Meeting. Below is a brief outline of the Governing Body structure for Llangynidr School:

Sub-committee structure

FINANCE COMMITTEE

Looks at the school's budget and works with Powys County Council to make the most of the school's funding and to make savings where possible.

PREMISES, HEALTH & SAFETY COMMITTEE

Oversees the school buildings and grounds, any maintenance issues and also acts quickly in the case of any health & safety issues.

STAFFING COMMITTEE

Has an overview of the school's staff, recruits any new people and deals with any other staff issues like discipline or grievance. There is also a **STAFFING APPEALS COMMITTEE**.

POLICY REVIEW & GOVERNOR EFFECTIVENESS COMMITTEE

Regularly checks and reviews all the school and Governing Body policies to make sure they do the right job, as well as examining how the Governing Body works overall.

PUPIL DISCIPLINARY & EXCLUSION COMMITTEE

This is a statutory committee required by the Welsh Government.

HEADTEACHER PERFORMANCE PANEL

Reviews the Headteacher's performance and sets targets as part of an appraisal process. There is also a **HEADTEACHER PERFORMANCE APPEALS PANEL**.

SCHOOL STANDARDS PANEL

Reviews the school's data as well as moderation from the school's peer groups. Has the same members as the Headteacher Performance Panel and includes Curriculum Governors.

Responsibilities for individual governors

CHILD PROTECTION OFFICER

Has an overview on any issues of child protection – a governor who is trained to a high level in child protection.

PUPIL ATTENDANCE OFFICER

Keeps track of our attendance data – important information for future Estyn reports.

COMMUNITY LINK OFFICER

Ensures the school maintains strong links with the community, especially the Friends PTA.

CURRICULUM GOVERNORS

Review the school's work within the curriculum and the school results data – we currently have two, one for numeracy & science and one for literacy.

COMPLAINTS OFFICER

As part of our complaints procedure, we have an officer available in case any complaint hasn't been resolved by the Headteacher.

EQUAL OPPORTUNITIES OFFICER

Makes sure the school is complying with our equal opportunities policy as well as the law.

ADDITIONAL LEARNING NEEDS (ALN) OFFICER

Ensures the school is carrying out requirements for any pupils with additional learning needs and also makes sure the school is adequately funded for ALN.

The school's standards

September 2014 to July 2015

Llangynidr Primary School has continued to provide children with a very good standard of education in 2014-2015. Last year, there were a total of 128 pupils in school, 6.7% were eligible for free school meals and attendance stands at 95.42% for the last academic year. The school is part of a 'family' group of 10 similar schools from across Wales.

The school is assessed on the level achieved by pupils at two stages of primary school life, Foundation Phase – end of Year 2 – and at Key Stage 2 – end of Year 6. This data is then used to form a picture of the school's performance by comparing it with other schools in the 'family', the Powys average and Wales average.

FOUNDATION PHASE

The Foundation Phase Performance Indicator – which the Welsh Government uses to measure how well pupils across Wales do in the three main areas of learning – was 95%.

Additional Learning Needs Coordinator (ALNco) was Mrs Sian Shepherdson. The ALNco evaluates provision for pupils with Additional Learning Needs to ensure that resources are utilised effectively to support children's progress. The ALNco works in close collaboration with professional colleagues in the Local Authority and specialist support services to ensure pupils with ALN achieve their full potential.

PUPIL ATTENDANCE

Attendance 2014-15 - 95.42%.

Authorised absences 1.11%.

Unauthorised absences 3.47%.

Attendance information is gathered from the daily register. Authorised absences include illness, hospital appointment or other special circumstances, such as a bereavement. Unauthorised absences occur if an absence cannot be explained or the reason is not one that we are able to authorise, including holidays.

Pupil attendance in school is monitored by the local authority and Welsh Government and figures are reported annually. The Welsh Assembly Government took the decision last year to issue fixed penalty notices to parents whose child's attendance falls below 90% in an academic year and Llangynidr School adopted this policy on the advice of ERW, the educational consortium which includes Powys.

EXTRA CURRICULAR ACTIVITIES

Pupils enjoyed a range of additional activities after school, many of which were run by staff. Year 5/6 pupils attended a residential trip to Morfa Bay.

SCHOOL POLICIES

The school is required to hold a number of statutory policies which have all been updated as part of a review cycle. Policies are approved by and formally adopted by the school's Governing Body, and copies are available from the school office and are also available for download on the school's website.

Estyn inspection September 2015

The school was inspected by Estyn in September and the results have just been released – Estyn says the school is a **GOOD** school with **GOOD** prospects for improvement. In Estyn terms, the label 'good' means – 'many strengths and no important areas requiring significant improvement'. The whole process was really very positive and, while there are some suggestions of ways to improve further, the Governing Body has expressed approval of what Mrs Jenkins and the staff are doing at the school – thanks for all your hard work!

The School Improvement Plan

September 2014 to July 2015

PRIORITY 1 – To improve Level 4 writing at Key Stage 2 from 92% to a minimum of 94% to be in line with family average. *Long-term planning, assessment and monitoring was put in place – all learners in the Year 6 cohort achieved Level 4 in English.*

PRIORITY 2 – To implement the Literacy & Numeracy Framework. *Governor learning walks have assessed that LNF implementation has been quite positive.*

PRIORITY 3 – To identify More Able & Talented (MAT) pupils across the school and to improve the provision for MAT pupils in order to maintain and improve standards. *Level 5 results for all core subjects at Key Stage 2 and Outcome 6 at Foundation Phase significantly improved.*

PRIORITY 4 – To introduce and develop assessment procedures in order to track pupils. *INCERTS has been implemented in order to monitor pupil progress from starting at the school until the end of Key Stage 2.*

PRIORITY 5 – To develop and strengthen leadership roles at all levels. *All staff have clear roles and responsibilities and have been developed with as much training as school budgets will allow.*

Powys County Council assesses the school fully every autumn, with an interim assessment in the spring, and publishes the results in January – it is expected that the school will do well this year, coupled with an improvement in the school's results collated by the Welsh Assembly Government.

School Improvement Plan ongoing

The Governing Body considers the School Improvement Plan as an ongoing part of its assessment of the school so, in conjunction with the Headteacher, we have highlighted the following areas for improvement in the current academic year (2015-2016):

- To raise standards in Mathematics at Outcome 6 and Level 5 to reflect school results in English.
- To improve reading and writing at Level 5 for girls at KS2.
- To develop and improve ICT skills to achieve digital competency.
- To improve pupils' involvement in their learning... develop the 'pupil voice'.

Parent and pupil questionnaires

In the summer, the school sent out questionnaires to both parents and pupils and the results will be used to help formulate the School Improvement Plan and make changes to areas of school life identified in the questionnaires.

The full results of the survey and the suggestions for areas to improve are attached at the end of this document.

School buildings & grounds

The appearance of the school has been transformed over the last year. The consistent and successful fundraising organised by the Friends and supported fully by parents has resulted in many improvements, particularly in our outdoor space. There has been new playground equipment for both Foundation Phase and Junior areas and the new outdoor learning classroom for our Nursery/Reception children is a big hit with the teachers and children alike.

Powys LA has begun a new window replacement programme, which hopefully will continue this year so that all the windows have been replaced. Inside the school, volunteer parents have helped staff paint doors and classrooms. To add to our safeguarding measures a new alarm has been installed so that all classrooms and playgrounds can raise an alarm if necessary.

Our membership of Property Plus – the Powys scheme for building maintenance – has resulted in many smaller jobs being fixed in a timely manner and some additional electrical and other works have been undertaken to ensure our teaching areas in classrooms are maximised.

The school's budget and finances

April 2014 to March 2015

As with all government funding, the austerity measures continue to affect us and this year continued to be a huge challenge of managing resources while endeavouring to maintain our high standards within the school. Of course, the Estyn Inspection has shone brightly as an indication that it is possible to continue to deliver excellence despite the strenuous demands upon resources.

I am delighted to acknowledge the huge contribution made by the Headteacher and staff in endeavouring to make every economy possible in order to meet those challenges. As far as I'm concerned, just about every pencil and piece of paper is accounted for in terms of cost and we continue to look carefully at every investment that we make. Of course, there comes a point at which there is simply nothing left to cut. Inevitably, we will be asked to look further and I can only hope that we will be able to address what is being asked of us.

As always, the Friends' contribution is entirely invaluable to the welfare of the school and we are a long way from the days where the objective was to ask benefactors to provide 'the icing on the cake'. Rather, the contribution from the Friends is now paying directly for educational equipment necessary to maintain our objectives, including the fabric of the school. Again, an enormous 'thank you' is due to all those who helped organise and support Friends' activities.

Looking forward, and as with all schools, I'm afraid to say that the financial headwinds continue to be very strongly set against us. While it appears often as little consolation, we are in decent shape when compared with some of our peers and certainly are able to demonstrate good financial acumen to Powys with a credible financial plan for the foreseeable future. Having said that, we know that there will be unforeseen challenges to come which will need to be dealt with.

That plan is dependent on keeping good school pupil numbers and, of course, that in itself is dependent upon our ability to maintain excellent standards. For our part, as a Governing Body, we remain focused on ensuring that we will be entirely diligent in respect of those limited costs over which we have some control.

– The capitation budget is the budget with which the school buys all the teaching and learning materials, computers and other resources for the whole school.

– Salaries and wages include all teaching staff, learning support assistants, secretarial staff, breakfast club staff and midday supervisors.

– The premises expenditure includes repairs and maintenance, cleaning, electricity, gas, rates, water/sewerage and any furniture purchases.

– LA support services include advice and support on legal, financial and personnel matters for which we pay a fee to the local authority.

The school has a comprehensive prospectus available for all parents who are thinking of sending their children to Llangynidr.

School admissions

Powys County Council is responsible for admissions to the school and uses a three-year register to determine our school numbers in subsequent years – this information is then used to delegate the school's budget for the year. Parents should apply to the school for admission by January in the year before the academic year in which their child will be four – a full copy of the school's admission arrangements can be obtained from Akemi. The school currently has 133 pupils.

School Council & Eco committee

The School Council and Eco committee have been voted in for this year and will meet fortnightly with Mrs Cathy Davies. They will be working with pupils, staff and the Headteacher to ensure pupils' voices are heard.
